Assignor represents it is the legal owner of all right, title and interest in and to the Mark and has the right to assign the Mark.



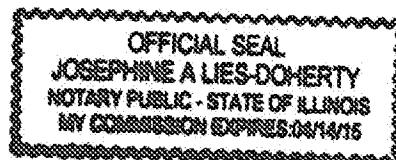
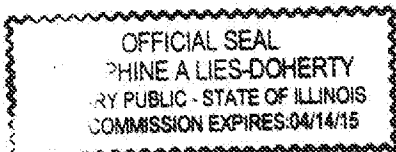
