

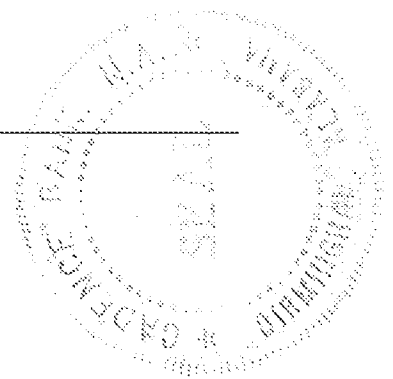

3. The main office of Cadence Bank, National Association is 17 20<sup>th</sup> Street North, Birmingham, Alabama 35203.


