This Notice of Trademark Security Interest, dated as of October 29, 2012, is made with regard to PRINCE CORPORATION, a Wisconsin corporation ("Debtor"), having an address for notice at 8351 County H, East, Marshfield, Wisconsin 54449 and WELLS FARGO CREDIT, INC. ("Lender"), having an address for notice at 730 Second Avenue South, 8<sup>th</sup> Floor, Minneapolis, Minnesota 55402.

R E C I T A L S:

Debtor and Lender have entered into an Amended and Restated Credit and Security Agreement dated as of October 18, 2012 (as the same may hereafter be amended, supplemented or restated from time to time, the "Credit Agreement") setting forth the terms on which Lender may now or hereafter make certain loans or other financial accommodations to or for the account of Debtor. The security interests granted therein continue security interests in Debtor's trademarks previously granted to Lender pursuant to both a Credit and Security Agreement dated March 25, 1999 and a Trademark Security Agreement dated March 25, 1999 to which Debtor and Lender are parties (the "Prior Security Agreements").

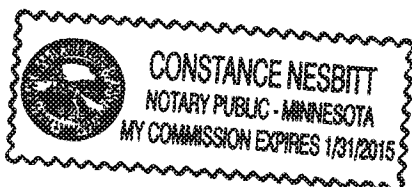
