## TRADEMARK AND PATENT SECURITY AGREEMENT

THIS TRADEMARK AND PATENT SECURITY AGREEMENT (the "Agreement") made as of October 24, 2012 by **VICTORY BREWING COMPANY**, a Pennsylvania corporation ("Grantor"), in favor of **FIRST NIAGARA BANK, N.A.**, as Administrative Agent for itself and the Lenders ("Secured Party") under the Credit Agreement referred to below.

### WITNESSETH

WHEREAS, Grantor has entered into that certain Credit Agreement dated as of the date hereof, among Grantor, as borrower, First Niagara Bank, N.A., as Administrative Agent and as a Lender (as defined therein), and the other Lenders party thereto (as amended, restated, modified or supplemented from time to time, the "Credit Agreement"), providing for the extensions of credit to be made to Borrower by Administrative Agent and Lenders; and

WHEREAS, pursuant to the terms of that certain Security Agreement dated as of the date hereof among Grantor and Secured Party (as amended, restated, modified or supplemented from time to time, the "Security Agreement"), Grantor has granted to Administrative Agent a security interest in substantially all of the assets of Grantor, including all right, title and interest of Grantor in, to and under all now owned and hereafter acquired trademarks and patents, together with the goodwill of the business symbolized by Grantor's trademarks and patents and all products and proceeds thereof, to secure the payment of all amounts owing by Borrower under the Credit Agreement.

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantor agrees as follows:

1. Incorporation of Credit Agreement and Security Agreement. The Credit Agreement and Security Agreement and the terms and provisions thereof are hereby incorporated in their entirety by this reference. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Credit Agreement.

2. Grant and Reaffirmation of Grant of Security Interests. To secure the payment and performance of the Obligations under the Credit Agreement, Grantor hereby grants to Administrative Agent and hereby reaffirms its grant pursuant to the Security Agreement of a continuing security interest in Grantor's entire right, title and interest in and to the following, whether now owned or existing or hereafter created, acquired or arising:

(i) each now owned or hereafter acquired trademark, trademark application, patent and patent application, including, without limitation, those listed on Schedule 1 annexed hereto (such trademarks and trademark applications, the "Trademarks" and such patents and patent applications, the "Patents"), together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or Patent (as applicable), or (b) injury to the goodwill associated with any Trademark.

3. Covenants. Grantor agrees not to (a) sell, grant any option, assign or further encumber its rights and interest in the Trademarks or Patents, or (b) except in exchange for valuable consideration in the ordinary course of business, license its rights and interest in the Trademarks or Patents, in each case without prior written consent of Secured Party.

4. Representations and Warranties. Grantor hereby represents and warrants that the Trademarks and Patents listed on Schedule I attached hereto constitute all trademark registrations, trademark applications, material unregistered trademarks, patents and patent applications owned or registered to Grantor.

5. Termination. This Agreement shall continue in effect until all of the Obligations are indefeasibly paid and satisfied in full and the Credit Agreement is terminated.

Nothing herein contained shall obligate Secured Party to use or exercise any rights granted herein. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Credit Agreement.

This Power of Attorney is given and any action taken pursuant hereto is intended to be so given or taken pursuant to and subject to the provisions of the Credit Agreement and other Loan Documents.

Grantor hereby unconditionally ratifies all that such attorney shall lawfully do or cause to be done following the occurrence and during the continuance of an Event of Default by virtue hereof and in accordance with the terms of the Trademark and Patent Security Agreement, the Credit Agreement and the other Loan Documents.

This Power of Attorney is coupled with an interest and shall be irrevocable for the life of the Trademark and Patent Security Agreement.
