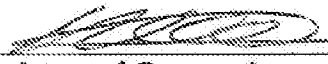

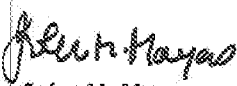

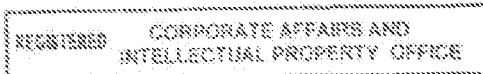

RESOLVED as a Special Resolution of CONSTELLATION BRANDS, INC.:

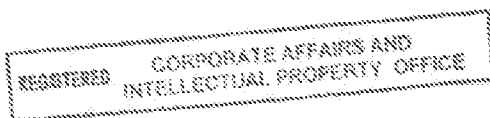
