RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank of America, N.A., a national banking association, as Administrative Agent ("Agent"), whose address is 901 Main Street, 14th Floor, Dallas, Texas 75202, pursuant to that certain Credit Agreement dated as of November 14, 2008, among Agent, the Lenders party thereto, and Orange County Container Group LLC, a Delaware limited liability company (the "Grantor"), and OCC Group, LLC, a California limited liability company, as amended by that First Amended and Restated Credit Agreement dated as of March 31, 2011 (such agreements, together with all amendments, restatements and other modifications thereto, the "Credit Agreement"), does hereby terminate and forever discharge and release all of its right, title and interest in, to and under that specific intellectual property collateral shown on Exhibit "A" attached hereto, namely, those trademarks and patents listed on Exhibit "A" (the "Released Intellectual Property Collateral"), arising from that certain Intellectual Property Security Agreement dated as of November 14, 2008, between Agent and the Grantor, which was recorded in the United States Patent and Trademark Office on or about December 4, 2008, against United States trademarks at Reel/Frame Numbers 003899/0571, as amended by that certain First Amendment to Intellectual Property Security Agreement dated as of March 31, 2011 (such agreements, together with all amendments, restatements and other modifications thereto, the "Security Agreement"), which was recorded in the United States Patent and Trademark Office on or about June 10, 2011, against United States patents at Reel/Frame Numbers 026428/0547, and recorded in the United States Patent and Trademark Office on or about December 19, 2011, against United States trademarks at Reel/Frame Numbers 04689/0907. The Agent hereby retransfers and reassigns to the Grantor, without representation or warranty, all of the Agent's right, title and interest in, to and under the Released Intellectual Property Collateral.

The Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
