## **INTELLECTUAL PROPERTY ASSIGNMENT**

**THIS INTELLECTUAL PROPERTY ASSIGNMENT** (the "Assignment") is made and entered into as of November 30, 2012 (the "Effective Date"), by and between Quick Fuel Technology, Inc., a Kentucky corporation ("Quick Fuel"), B Squared Development, LLC, a Kentucky limited liability company ("B Squared"), Benebe, Inc., a Kentucky corporation ("Benebe", and together with Quick Fuel and B Squared, each an "Assignor" and collectively the "Assignors"), on the one hand, and QFT Holdings, Inc., a Delaware corporation (the "Assignee"), on the other hand. Capitalized terms not defined herein shall have the meanings ascribed to them in the Purchase Agreement (as defined below).

**WHEREAS**, in connection with that certain Asset Purchase Agreement dated as of the date hereof (as may be amended, modified or supplemented, the "Purchase Agreement"), by and among Marvin Benoit, an individual, Quick Fuel, B Squared, Benebe and Assignee, Assignee wishes to acquire from the Assignors, and the Assignors wish to assign to Assignee, all of the Assignors' entire right, title and interest in and to all Proprietary Rights owned by the Assignors, including without limitation: (i) the patents and patent applications set forth on Schedule A ("Patents"); (ii) the trademarks and trademark applications set forth on Schedule B, together with all rights derived therefrom, including statutory, common law and contractual rights, and any and all goodwill connected with and symbolized by, in, to and under any of the foregoing ("Trademarks"); and (iii) the domain name registrations set forth on Schedule C ("Domain Names"). The Proprietary Rights set forth in this paragraph are collectively referred to herein as the "Company Proprietary Rights."

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Each of the Assignors hereby contributes, assigns, transfers, conveys, delivers and sets over to Assignee, such Assignors' entire right, title and interest in and to the Company Proprietary Rights, including all rights therein that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, together with all income, royalties, damages or payments accrued, due or payable as of the Effective Date or thereafter with respect thereto, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Company Proprietary Rights, with the right to sue for, and collect the same, in each case, for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by such Assignor if this Assignment had not been made.

Each of the Assignors hereby requests that the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, record Assignee as the assignee and owner of the Patents and Trademarks.

The Assignors shall take all reasonable actions, and provide to Assignee, its successors, assigns, and other legal representatives, reasonable cooperation and assistance, at Assignee's request and expense (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney and

other documentation) as may be reasonably required to effect the assignment to Assignee of the Company Proprietary Rights (including the Patents, Trademarks and Domain Names) in accordance with the terms hereof.

Neither the making nor the acceptance of this conveyance, assignment, transfer and assumption shall enlarge, restrict or otherwise modify the terms of the Purchase Agreement or constitute a waiver or release by any party to the Purchase Agreement of any obligations or duties imposed thereby. For the avoidance of doubt, in the event of any conflict or ambiguity between the provisions of this Assignment, on the one hand, and the provisions of the Purchase Agreement, on the other hand, the Purchase Agreement shall control.

The law of the State of Delaware shall govern all questions concerning the construction, validity, interpretation and enforceability of this Assignment, and the performance of the obligations imposed by this Assignment, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Delaware or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Delaware.


