## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 3, 2012, is made by Sankaty Advisors LLC, in its capacity as collateral agent for the Purchasers (the "Collateral Agent").


