ARTICLES OF AMENDMENT OF
ARTICLES OF INCORPORATION OF
FIVE STAR INDUSTRIES, INC.

TO THE SECRETARY OF STATE
OF THE STATE OF IOWA:

Pursuant to Section 1001 of the Iowa Business Corporation Act, the above-named corporation (the "Corporation") hereby adopts the following amendment to the Corporation's Articles of Incorporation:
