## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 30, 2012 (“Release”), is made by **BANK OF AMERICA, N.A.** (as successor to Bank of America National Trust and Savings Association) (“Bank”), in favor of **SUPER STORE INDUSTRIES**, a California general partnership (“Grantor”).

**WHEREAS**, pursuant to that certain Security Agreement dated as of June 24, 1993 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Grantor and Bank, Grantor granted to the Bank a security interest in all of Grantor’s right, title and interest in, to and under the Trademarks, goodwill associated with the Trademarks, and Proceeds of the foregoing (“Trademark Collateral”); and

**WHEREAS**, the Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on July 16, 1993 at Reel 1003 Frame 0184.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Bank and Grantor agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement.

**SECTION 2. Termination and Release.** Bank hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.


**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of California.

**SECTION 4. Acknowledgement.** The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Security Agreement dated as November 30, 2012 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time) by and among the Obligors party thereto (as defined therein) and Bank of America, N.A.
