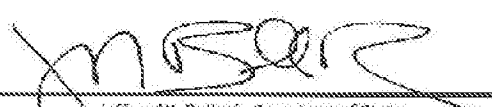

FIRST: That at a meeting of the Board of Directors and sole stockholder of the Corporation, notice of which was waived in accordance with Section 229 of the DGCL, the Board duly adopted and approved resolutions proposing and declaring advisable the following amendment to the Corporation's Certificate of Incorporation:

"RESOLVED, that the Certificate of Incorporation of the Corporation be amended by changing Article First thereof to read in its entirety as follows:

FIRST: The name of the corporation is CGI JCF, INC."

SECOND: That said amendment was duly adopted at the meeting by the Corporation's sole stockholder in accordance with Section 242 of the DGCL.

THIRD: That this Certificate of Amendment to the Certificate of Incorporation and the aforementioned amendment shall become effective upon filing with the Secretary of State of the State of Delaware.
