GRANT OF SECURITY INTEREST (TRADEMARKS)

The undersigned, **PETROSKILLS, LLC**, an Oklahoma limited liability company (the "**Grantor**"), and **WEBSTER BANK, NATIONAL ASSOCIATION** (the "**Administrative Agent**") are parties to a Security Agreement, dated as of November 30, 2012 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**").

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Collateral made and granted hereby are set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
