

BE IT FURTHER RESOLVED, that this Amendment to Amended and Restated Articles of Incorporation shall be effective on December 1, 2012.

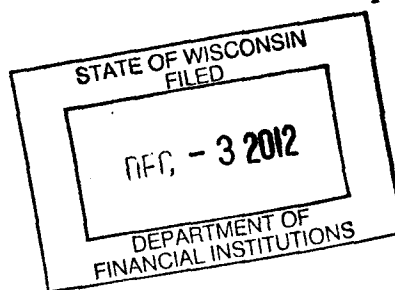
