## TRADEMARK ASSIGNMENT

*THIS TRADEMARK ASSIGNMENT* (the "Assignment"), effective as of November 7, 2012 (the Effective Date") is made between Raceway Media, LLC, a Massachusetts Limited Liability Company ("Assignor"), and Live Wideopen, LLC, a Delaware Limited Liability Company ("Assignee").

*WHEREAS*, Assignor and Assignee desire to confirm of record the assignment of the Marks and the Goodwill to Assignee.

*NOW, THEREFORE*, in consideration of the foregoing recitals, the mutual covenants and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:



Assignor hereby assigns to Assignee all right, title and interest in and to the Marks, together with: (i) the Goodwill; (ii) all causes of action, claims and demands and other rights for, or arising from, any infringement or misappropriation, including past infringements and misappropriations, of the Marks; and (iii) any royalties or other consideration owed in connection with use of the Marks after the Effective Date.
2. Assignor further agrees without further consideration to perform such other lawful acts and to execute such further assignments and other lawful documents as Assignee may from time to time reasonably request to fully effect this Assignment and to permit Assignee to be duly recorded as the registered owner of the Marks, Goodwill and all other rights hereby conveyed.
3. Subject to the terms hereof, Assignee accepts such assignment of the Marks and Goodwill.
