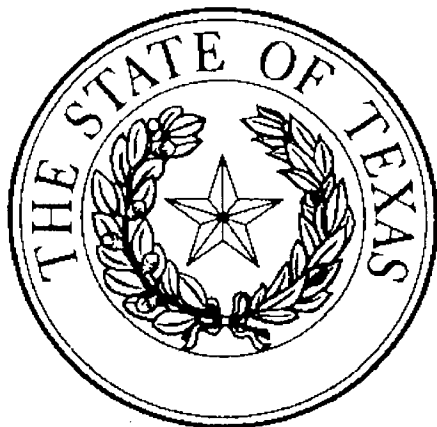

**ARTICLES OF AMENDMENT  
TO  
THIRD AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF  
BBS TECHNOLOGIES, INC.**

**Corporations Section**

BBS Technologies, Inc., a Texas corporation (the "Corporation"), pursuant to the provisions of Section 3.051 of the Texas Business Organizations Code (the "TBOC"), hereby amends its Third Amended and Restated Articles of Incorporation, as amended heretofore, and for that purpose, submits the following statement:

1. The name of the corporation is BBS Technologies, Inc.
2. ARTICLE I of the Third Amended and Restated Articles of Incorporation is hereby amended in its entirety so as to read as follows:  
  
"The name of the corporation is Idera, Inc."
3. ARTICLE III of the Third Amended and Restated Articles of Incorporation is hereby amended in its entirety so as to read as follows:  
  
"The purpose for which Idera, Inc. (the "Corporation") is organized is for the transaction of any or all lawful business for which corporations may be incorporated under the Texas Business Corporation Act (together with any successor act or law, the "TBCA")."
4. The amendments to the Third Amended and Restated Articles of Incorporation have been approved in the manner required in the TBOC and the Corporation's governing documents.
5. These Articles of Amendment were duly adopted by the shareholders of the Corporation on January 26, 2012.
6. The number of shares outstanding was 23,510,971, consisting of 15,517,393 shares of Common Stock, 2,445,308 shares of Series A Preferred Stock and 5,548,270 shares of Series B Preferred Stock and the number of shares entitled to vote on the Articles of Amendment was all such 23,510,971 shares. Written consent to the adoption of these Articles of Amendment has been given, in accordance with the provisions of Section 6.202 of the TBOC, by the holders of at least two-thirds of the outstanding shares of the shares entitled to vote on this matter, and any written notice required by Section 6.202 of the TBOC has been given.
