TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made as of February 21, 2012, by and between Whatman International Ltd., a subsidiary of the General Electric Company having offices at Springfield Mill, James Whatman Way, Maidstone, Kent, ME14 2LE, United Kingdom ("Assignor"), and Hichrom Limited, with its principal place of business at 1 The Markham Centre Station Road, Theale Berkshire UK RG7 4PE ("Assignee").

WHEREAS, Assignee desires to acquire from Assignor, and Assignor wishes to transfer to Assignee, all right, title and interest in and to the United States registration of Partisphere (Reg. No. 1428906), the United Kingdom registration of Partisphere (Reg. No. 1232989) and the Canadian registration of Partisil (Reg. No. 222937) (collectively, the "Assigned Mark").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably assigns, sells, and transfers to Assignee, all of Assignor's right, title, and interest in and to the Assigned Mark, including all state and common law rights, together with the goodwill of the business symbolized by the Assigned Mark, and the registrations and applications therefor, including any renewals and all rights to damages and profits, due or accrued, arising out of past, present, or future infringements of said Assigned Mark, and the right to sue for and recover the same, for sale and marketing of the goods covered by the registrations ("Assigned Mark Field"). Assignee shall fully indemnify and hold Assignor harmless against any claims, actions, demands, proceedings, losses, damages, costs or expenses and other liabilities (including reasonable legal costs) incurred as a result of the use of the Assigned Mark by Assignee as permitted under the terms of this Assignment.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as assignee and owner of the Assigned Mark with the United States Patent and Trademark Office, United Kingdom and Canada.

Assignor agrees to execute and deliver, or cause to be executed and delivered, such documents and other papers and take, or cause to be taken, such further actions as may be reasonably required to carry out the provisions of this Assignment and give effect to this Assignment.

This Assignment only transfers the Assignor's right, title, and interest in the Assigned Mark to Assignee under the terms and conditions recited herein. Assignor disclaims any and all warranties, express or implied, with respect to the Assigned Mark and Assignor's interests therein.

This Assignment shall be governed by, and construed and interpreted in accordance with, the laws of England and Wales.
