GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, **Firth Rixson Limited**, a limited liability company incorporated in England and Wales with registered number 00230737 (the "Grantor") and having its registered office at Firth House, P.O. Box 644, Meadowhall Road, Sheffield, United Kingdom S91JD, pursuant to, and in conjunction with, clause 5.3 (*Register of Trademarks*) of the Debenture entered into between the Grantee (as defined below) and certain other parties dated as of December 7, 2012, as amended, modified or supplemented from time to time (the "Debenture"), hereby grants and assigns to **Lloyds TSB Bank plc**, as security agent, (the "Grantee"), with offices at 10 Gresham Street, London United Kingdom EC2V 7AE, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:

- (i) each United States registered trademark or service mark and applications thereof, including the registered trademarks referred to in Schedule A attached hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark or service mark;
- (ii) all claims for, and rights to sue for, past, present or future infringement of any of the foregoing; and
- (iii) all income, royalties, damages and payments now or hereafter due or payable with respect to any of the foregoing, including, without limitation, damages and payments for past, present or future infringements thereof and payments and damages under all licenses in connection therewith.

This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. In proving this Assignment in any judicial proceedings, it shall not be


necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.

The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Debenture, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Assignment are deemed to conflict with the Debenture, the provisions of the Debenture shall govern.
