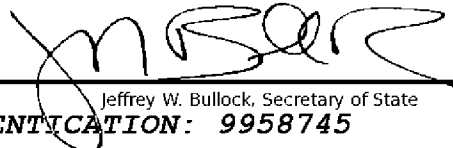

FOURTH: That the merger shall be effective at 10:00 a.m. on November 2, 2012.

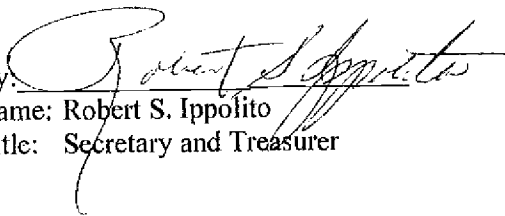
