C/G Electrodes LLC, a Delaware limited liability company formed on the 26th day of November, 2001, hereby certifies as follows pursuant to the provisions of Section 264 of the General Corporation Law of the State of Delaware and Section 18-209 of the Delaware Limited Liability Company Act:

1. Pursuant to an Agreement and Plan of Merger dated as of April 28, 2010 (as amended, the "Merger Agreement") by and among C/G Electrodes LLC and GrafTech Delaware III Inc. as the constituent business entities; GrafTech Holdings Inc.; GrafTech International Ltd.; the members of C/G Electrodes LLC named on Exhibit A to the Merger Agreement; and for limited purposes Nathan Milikowsky and Daniel Milikowsky, GrafTech International Ltd. and its affiliates are acquiring C/G Electrodes LLC by merger of GrafTech Delaware III Inc. with and into C/G Electrodes LLC.

2. The names and jurisdiction of formation or organization of each of the constituent business entities of the merger are as follows:

3. The Merger Agreement by and among the constituent business entities and the other parties thereto described above has been approved, adopted, certified, executed and acknowledged by each of C/G Electrodes LLC and GrafTech Delaware III Inc. as the constituent business entities.

4. Upon consummation of the merger, the surviving business entity of the merger shall be C/G Electrodes LLC (the "Surviving Entity"). The name of the Surviving Entity shall be C/G Electrodes LLC. Upon consummation of the merger, the Certificate of Formation of the Surviving Entity shall remain unchanged except as follows:

Article 1 thereof be, and hereby is, amended in its entirety to be and read as follows:

“1. The name of the limited liability company is GrafTech USA LLC.”

Article 2 thereof be, and hereby is, amended in its entirety to be and read as follows:

“2. The address of the registered office of the limited liability company in the State of Delaware is Corporation Trust Center, 1209 Orange Street, City of Wilmington, County of New Castle. The name of its registered agent at such address is The Corporation Trust Company.”

5. The merger shall be effective at 8:43 a.m., Eastern Time, on November 30, 2010.

6. The executed Merger Agreement is on file at the principal place of business of the Surviving Entity. The principal place of business of the Surviving Entity is located at 12900 Snow Road, Parma, Ohio 44130.

7. A copy of the Merger Agreement will be furnished by the Surviving Entity, on request and without cost, to any member or shareholder of either constituent business entity.
