MANAGER-MANAGED

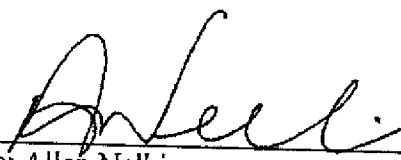
The Company is to be managed by its Manager or Managers in accordance with the provisions of the LLC Agreement and the Act.
