## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 11, 2012, by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, as administrative agent ("Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Assignment (as defined below).

### WITNESSETH:

WHEREAS, EXPRESS OIL CHANGE, L.L.C., a Delaware limited liability company, (the "Grantor") and Agent are parties to a Trademark Security Agreement dated as of June 16, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Assignment"), pursuant to which Grantor granted a security interest to Agent in certain trademarks ("Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on June 16, 2010, at Reel 4226, Frame 0197; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Rights and reassign the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Rights"):

(a) all of its Trademarks providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto;

i. all renewals and extensions of the foregoing;

ii. all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

iii. all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and the Trademark Rights.
