TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made as of November 20, 2012, by and between Wallcur, Inc., a California corporation ("Assignor") and Wallcur LLC, a California limited liability Assignee ("Assignee") as follows:

RECITALS

A. WHEREAS, Assignor has registered certain trademarks with the United States Patent and Trademark Office and the appropriate offices of certain countries foreign to the United States and has filed the applications for registration of certain trademarks with the United States Patent and Trademark Office and the appropriate offices of certain countries foreign to the United States, in each case as and to the extent set forth on Exhibit A hereto (collectively, the "Marks").

B. WHEREAS, Assignor desires to assign to Assignee all of the right, title and interest in and to the Marks set forth on Exhibit A hereto, together with the goodwill of the business pertaining thereto.

AGREEMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

(a) Assignor does hereby transfer, convey, assign and deliver to the Assignee all of Assignor's right, title and interest in and to the Marks, together with the goodwill of the business pertaining thereto, the same to be held by the Assignee for the Assignee's own use and enjoyment, and for the use and enjoyment of the Assignee's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if the assignment set forth herein had not been made, together with all claims for damages by reason of past infringements of the Marks, along with the right to sue for and collect such damages for the use and benefit of the Assignee and its successors, assigns and other legal representatives.


(b) Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and, in the case of any trademark registrations, or applications therefor, made or filed with any office of any country or countries foreign to the United States, any officer of such country whose duty it is to issue trademarks or other evidence or forms of intellectual property protection or applications as aforesaid, to issue the same to the Assignee and its successors, assigns and other legal representatives in accordance with the terms of this instrument.


