## ASSIGNMENT OF SERVICE MARKS

**THIS ASSIGNMENT OF SERVICE MARKS** is made and effective as of June 30, 2012, by and between **MEDCATH INCORPORATED**, a North Carolina corporation, whose principal business address is 10720 Sikes Place, Suite 300, Charlotte, North Carolina 28277 ("Assignor"), and **CCG OF CALIFORNIA, LLC**, a Delaware limited liability company, whose principal business address is 3401 West End Avenue, Suite 310, Nashville, Tennessee 37203 ("Assignee").

WHEREAS, Assignor is the record owner of the service marks set forth in Exhibit A attached hereto (the "Marks"); and

WHEREAS, in connection with the acquisition of all of the membership interests owned by HBBF, Inc., a North Carolina corporation and an affiliate of Assignor ("Seller") in Heart Hospital of BK, LLC, a North Carolina limited liability company ("HBBK"), pursuant to that certain Debt and Equity Purchase Agreement, entered into as of June 30, 2012, by and among Assignee, Seller, MedCath Finance Company, LLC, a North Carolina limited liability company, and, for the limited purposes set forth therein, Cardiovascular Care Group, Inc., a Delaware corporation, and MedCath Corporation, a Delaware corporation, Assignee is desirous of acquiring and using the Marks and all goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest it may now have, may ever have had or may ever have, in and to the Marks and the registrations thereof, together with all related common law rights and the goodwill of the business symbolized thereby, including all rights to sue and recover for past infringements thereof. The rights hereunder are assigned free and clear of all liens.

Assignor further agrees that Assignor will, without demanding any further consideration therefor, at the request and expense of Assignee, perform all reasonable and proper additional acts and execute any additional documents which Assignee may require in order to transfer and assign all of Assignor's rights, title and interest in and to the Marks to Assignee, its successors or assigns. Assignor hereby consents to the recordation of this Assignment and acknowledges that all official documents and communications relating to the Marks will be sent to Assignee, its attorneys, agents, successors and assigns.

This assignment will be governed by and construed in accordance with the laws of the State of North Carolina without regard to any conflicts of law principles and it may be executed in one (1) or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same document.
