SECOND: The text of each amendment adopted is:

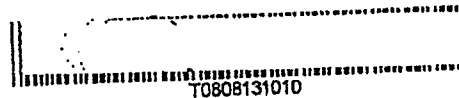
To amend Article FIRST of the Corporation's Articles of Incorporation by deleting said Article FIRST in its

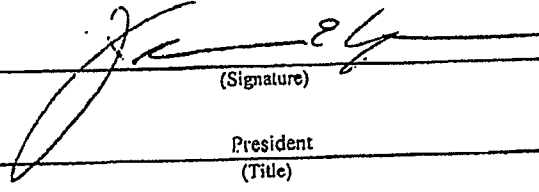

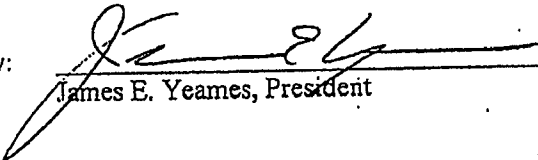
