**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

TERMINATION AND RELEASE, dated as of December 4, 2012, from Prudential Financial, Inc., a New Jersey corporation (the "Company") and BRER Affiliates LLC, fka Prudential Real Estate Affiliates, Inc., a Delaware limited liability company ("BRER Affiliates").

WITNESSETH:

WHEREAS, pursuant to the terms and conditions of (i) the Pledge and Security Agreement dated as of December 6, 2011, by and among the Parties and the other grantors party thereto (the "General Security Agreement") and (ii) the Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of December 6, 2011 ("Notice of Grant", and collectively with the General Security Agreement, the "Security Agreements"), BRER Affiliates granted to the Company a lien on and security interest in, certain Trademarks (as defined in the Notice of Grant), all goodwill associated therein and including, without limitation, those items listed on Schedule I hereto) and to the extent not otherwise included, all products, proceeds, substitutions and replacements of the foregoing (collectively, the "Trademark Collateral"); and

WHEREAS, the Notice of Grant was recorded in the Trademark Division of the United States Patent and Trademark Office on December 6, 2011 at Reel 4673, Frame 0115; and

WHEREAS, the Company now desires to terminate and release the entirety of its security interest in and to the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Company hereby states as follows:

1. Release of Security Interest: The Company hereby terminates, releases and discharges its security interest in the Trademark Collateral, and any right, title or interest of the Company in such Trademark Collateral shall hereby cease and become void.

2. Further Assurances: The Company shall execute and deliver to BRER Affiliates all further releases and other documents (including without limitation Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of such security interest.
