RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "*Release*") is made as of December 13, 2012, by ALDINE SBIC FUND, L.P., Delaware limited partnership (the "*Secured Party*"), in favor of Gold Standard Baking, Inc., an Illinois corporation (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated June 6, 2008, which was recorded at the United States Patent and Trademark Office on June 6, 2008 at Reel 3791 and Frame 0689, and that certain Patent, Copyright, License and Trademark Agreement dated December 29, 2011, which was recorded at the United States Patent and Trademark Office on January 5, 2012 at Reel 4692 and Frame 0196 (collectively the "*Security Agreements*"), Grantor granted to the Secured Party security interests in and to all of Borrower's right title and interest, to, and under certain Marks and Trademarks, and the goodwill associated with the Marks and Trademarks (collectively, the "*Trademarks*"), including, without limitation, the Trademarks set forth in Schedule 1; and

WHEREAS, the Grantor has requested that the Secured Party release its liens on the Trademarks.


