ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS is made effective by and between:

1. **Eric R. Perkins**, solely in his capacity as Chapter 7 Trustee (the "Trustee") of the **ESTATE OF SPORTCRAFT LTD.** (the Debtor"), in the United States Bankruptcy Court for the District of New Jersey under Case Number 11-46684 (NLW), having an address at c/o McElroy , Deutsch, Melvaney & Carpenter, LLP, 40 West Ridgewood Avenue, Ridgewood, New Jersey 07450 (the "Assignor").
2. **TSA Stores, Inc.**, a Delaware Corporation with an address at 1050 West Hampden Avenue, Englewood, Colorado 80110 (the "Assignee").

WHEREAS

- A. Pursuant to the bankruptcy of the Debtor, the Office of the United States Trustee appointed Assignor as the Trustee of Debtor's estate, which estate includes certain trademark assets of Debtor's wholly owned subsidiary, Classic Sports Companies, Inc.
- B. Assignee has expressed an interest in acquiring the trademark assets of Classic Sports Companies, Inc. that are listed in Schedule A (the "Marks").
- C. Assignor is desirous of assigning the Marks to Assignee, and Assignee is desirous of obtaining, all right, title and interest in and to the Marks

IT IS AGREED as follows:

For \$10.00 and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, Assignor, solely in his capacity as Trustee, hereby grants, assigns and quitclaims to Assignee all right, title and interest existing in the Marks, including, without limitation, that portion of the business in connection with which the Marks are used and/or there is a *bona fide* intent to use the Marks, including the goodwill in the Marks, including the registrations and applications pertaining thereto, and including any rights that have accrued, or may in the future accrue.
