WHEREAS, the Assignee is desirous of acquiring any and all rights that Assignor may have in and to the Trademarks, together with the goodwill of the business symbolized by such Trademarks, and is also acquiring the business to which the said Trademarks pertain, which business is ongoing and existing;


NOW, THEREFORE, in consideration of the promises and mutual covenants contained in this Assignment and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

Assignor does hereby assign, transfer, and convey to Assignee all of Assignor's right, title, and interest in and to the Trademarks, including the registrations therefore, and all common law rights, together with the goodwill of the business symbolized thereby, and including without limitation Assignor's right to sue for and seek remedies against past, present, and future infringements of any or all of the foregoing and rights of priority and protection of interests therein under the laws of any jurisdiction worldwide, free and clear of all liens, claims, security interests, and other encumbrances.

Assignor agrees that it will execute and deliver to Assignee any documents necessary or requested by Assignee to complete the timely transfer of the Trademarks.
