## INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated as of September 10, 2012, is made and entered into by Elsevier STM Inc., a Delaware corporation ("Assignor") and International Medical News Group LLC, a Delaware limited liability company ("IMNG" or "Assignee").

### RECITALS

WHEREAS, Elsevier Medical Information LLC, a Delaware limited liability company ("Seller") owns 100% of the outstanding membership interests (the "Membership Interests") of IMNG;

WHEREAS, IMNG is engaged in the business of providing medical news from major medical meetings globally to medical professionals in major medical specialties through the media of print publication, websites, videos and newsletters (the "Business");

WHEREAS, pursuant to that certain Interest Purchase Agreement, dated as of the date hereof (the "Purchase Agreement"), Seller has agreed to sell to Quadrant HealthCom, Inc., a Delaware corporation ("Buyer") all of the Membership Interests of IMNG;

WHEREAS, Assignor is the owner of certain intellectual property which is used in the conduct of the Business as conducted as of the date hereof (the "Transferred Intellectual Property"); and

WHEREAS, Assignor desires to sell, transfer and assign to Assignee all right, title and interest of Assignor in and to the Transferred Intellectual Property, together with the goodwill associated therewith, and Assignee desires to acquire the Transferred Intellectual Property from Assignor;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and intending to be legally bound, the Assignor acknowledges as follows:

Assignment and Transfer. Assignor hereby assigns, transfers, conveys and delivers to Assignee all of Assignor's right, title and interest in and to:

(A) those certain trademarks and service marks, and all registrations thereof and applications for registration therefor, which are identified in Exhibit A hereto, together with the goodwill of the Business associated therewith (the "Trademarks");

(B) those domain names identified in Exhibit B hereto (the "Domain Names");

(C) those copyright registrations identified in Exhibit C hereto (the "Copyrights");


