TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, SmartLegalForms, Inc., (formerly known as Epoq US, Inc.), a Delaware corporation with an office at 6231 PGA Blvd, Suite 104-156, Palm Beach Gardens, FL 33418 ("Assignor") is the owner of the registered service mark MYLAWYER, Registration No. 2,685,146 and all common law rights herein (the "Mark"), for use in connection with providing legal information including legal forms over a global computer network; and

Assignor warrants that the Mark is in full force and good standing and there are no other assignment of rights or licenses granted under said Trademark, or known infringements by or against said Trademark. Assignor further warrants that SmartLegalForms, Inc. (formerly Epoq, US, Inc.) is the owner of the Mark, that the Corporation has full right and authority to transfer the Mark and that the Mark is transferred free and clear of all liens, encumbrances and adverse claims. Assignor agrees to execute and deliver at the request of the assignee, all papers, instruments and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's rights, title and interest in and to the Mark in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.
