INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement ("IP Assignment") is entered into as of April 30, 2012 by and between Chromaflo Technologies Corporation, an Ohio corporation ("Assignee"), and Colortrend USA LLC, a Delaware limited liability company ("Assignor").

PRELIMINARY STATEMENTS

1. Reference is hereby made to (i) that certain Share and Asset Purchase Agreement, dated as of March 5, 2012 (the "SPA"), by and among Evonik Degussa GmbH, a limited liability company organized under the laws of Germany ("Seller"), Evonik Degussa Corporation, an Alabama corporation, Chromaflo Acquisition Company LLC, a Delaware limited liability company ("Purchaser"), Chromaflo CT US LLC, a Delaware limited liability company, and Chromaflo Lockland Holdings LLC, a Delaware limited liability company, pursuant to which Purchaser or its affiliates will purchase from Seller all of the issued and outstanding shares of each of Evonik Colortrend B.V., a private company with limited liability existing under the laws of the Netherlands, Colortrend Australia Pty. Ltd ACN 079 823 313, a company organized and existing under the laws of Australia, and Colortrend Canada Inc., a corporation organized and existing under the laws of the Province of Ontario, and substantially all of the assets of Assignor, as applicable (the "Transaction") and (ii) that certain US Asset Transfer Agreement to be entered into by Assignor and Assignee on or about the date hereof.

2. The assets of Assignor being transferred to Assignee include all of Assignor's right and title to and interest in all patents, patent applications, trademarks, trademark applications, and internet domain names owned by Assignor as of the date hereof, (collectively, the "Colortrend USA IP Rights").

3. Assignee desires to obtain all of Assignor's right and title to and interest in all the Colortrend USA IP Rights.

AGREEMENTS

In consideration of the premises and the covenants set forth herein, and for other good and valid consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign and transfer to Assignee the Colortrend USA IP Rights (as listed in Schedule A) to the extent of Assignor's ownership interest therein, including, but not limited to, all of its worldwide right, title and interest, including all common law rights, and the rights of Assignor to file any and all subsequent applications based on Colortrend USA IP Rights, together with the goodwill of the business connected with the use thereof and symbolized thereby.

2. Authorization. Assignor hereby authorizes and requests the officials at the Patent and Trademark Offices in the United States and its territorial possessions and in any and all foreign countries to issue any and all enforceable rights, including Letters

Patent or registrations, when granted, to the Assignee for the sole use and benefit of the Assignee and of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made

3. Acceptance of Assignment. Assignee hereby accepts such assignment and transfer of the Colortrend USA IP Rights.

4. Further Assurances. Subject to Section 17 of the SPA, assignor shall execute such other or additional instruments of transfer or conveyance and undertake such other or additional actions in respect of the Colortrend USA IP Rights as are reasonably requested by Assignee, including any applicable forms of assignment necessary for filing before the U.S. Patent and Trademark Office and domain name registrars, or equivalent filings in foreign jurisdictions, to effectuate the full and complete transfer of the Colortrend USA IP Rights to Assignee.

5. No Representations or Warranties. No representations or warranties, express or implied, are being made in this IP Assignment, and the parties acknowledge and agree that the representations and warranties, if any, regarding the subject matter hereof are set forth in the SPA.


6. Governing Law. This Agreement shall be construed and enforced in accordance with the laws of the State of Delaware, without regard to principles of conflicts of law.


