4.2 Transferor hereby authorizes and requests the USPTO to issue the certificate of registration in respect of any trademark applications for the Marks to Transferee for its sole use, and for the use of its legal representatives and assigns, to the full end of the term for which such registration may be granted, as fully and entirely as the same would have been held by Transferor had this assignment not been made.

5. **WARRANTIES**

5.1 Transferor warrants and represents to Transferee that Transferor has good, marketable and unencumbered rights in the Marks.


