## TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT

Assignor agrees to execute any additional documents presented to Assignor by Assignee and to perform any other acts which are reasonably necessary to evidence or perfect the Assignment of this Assignment Agreement, including those reasonably necessary to effectuate the recordation of the Assignment of this Assignment Agreement, at Assignee’s sole expense.

This Assignment Agreement may be executed in two or more counterparts and by facsimile or PDF, each of which shall be deemed an original and all of which together shall constitute one instrument.

This Assignment Agreement shall be effective in the United States and Canada, and all foreign countries.

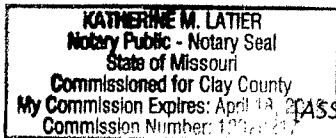


