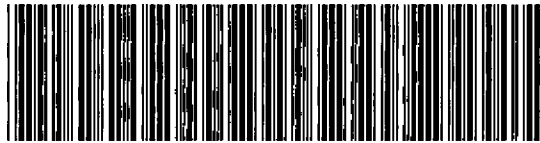




1. The name of the entity converting immediately prior to the filing of this Certificate of Conversion is Cellynne Corp.

ARTICLE IV - REGISTERED OFFICE AND AGENT AND ADDRESS


