**RELEASE OF SECURITY INTEREST IN TRADEMARK**

This RELEASE OF SECURITY INTEREST IN TRADEMARK ("Release"), dated as of August \_\_, 2012, is executed by FOURTH THIRD LLC, a New York limited liability company with offices at 375 Park Avenue, Suite 3304, New York, New York 10152 ("Fourth Third"), in favor of Allied Cash Holdings LLC, a Delaware limited liability company with offices at 200 SE First Street, Miami, Florida 33131 ("Allied").

**WITNESSETH:**

**WHEREAS**, Allied has executed a "Guarantee and Collateral Agreement" (the "Agreement") in favor of Fourth Third;

**WHEREAS**, pursuant to that Agreement, and to a "Supplement to Guarantee and Collateral Agreement (Trademarks)" executed by Allied and recorded with the U.S. Patent & Trademark Office ("USPTO") at Reel 003488 and Frame 0592 (the "Supplement"), Allied signed, pledged and granted a security interest in the ALLIED CASH ADVANCE trademark that is the subject of U.S. Registration Number 2,388,645 (the "Mark").

**WHEREAS**, Allied has satisfied in full the obligations secured by the Agreement.

**NOW, THEREFORE**, Fourth Third hereby agrees as follows:

1. Fourth Third hereby releases, terminates and discharges its security interest in the Mark.
2. The Supplement shall terminate and is hereby terminated.
3. Fourth Third will cooperate with Allied regarding the execution and delivery of such instruments reasonably required to give full effect to this Release.
