TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE (the "Release"), dated as of December , 2012, is made by JPMorgan Chase Bank, N.A. located at 270 Park Avenue, 4th Floor, New York, New York 10017, as administrative agent (the "Administrative Agent") for the several banks and other financial institutions (the "Lenders"), parties to the Credit Agreement, dated as of February 10, 2006 and amended and restated as of December 17, 2010 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") in favor of CCC Information Services Inc., a Delaware corporation, and ProcessClaims, Inc., a California corporation (together, the "Obligors"). Unless otherwise defined herein, terms used herein shall have the meaning ascribed to them in the Grant of Security Interest in Trademark Rights.

WHEREAS, pursuant to the Amended and Restated Guarantee and Collateral Agreement, dated as of February 10, 2006 and amended and restated as of December 17, 2010 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Administrative Agent pursuant to which the Obligors granted a security interest to the Administrative Agent in certain of its assets and agreed to deliver the Grants of Security Interest (as defined below).

WHEREAS, pursuant to the Grant of Security Interest in Trademark Rights, dated February 10, 2006 and the Amended and Restated Grant of Security Interest in Trademark Rights dated December 17, 2010 (together, the "Grants of Security Interest"), Obligors pledged and granted to the Administrative Agent for the benefit of the Administrative Agent and the Lenders a continuing security interest in, and a right of setoff against, and agreed to assign, transfer and convey, upon demand made upon the occurrence and during the continuance of an Event of Default without requiring future action by either party and to be effective upon such demand (the "Security Interest"), all of such Obligor's right, title and interest in, to and under the Trademarks (including, without limitation, those items listed in the attached Exhibit A) (collectively, the "Collateral");

WHEREAS, the Grants of Security Interest were recorded in the United States Patent and Trademark Office on February 14, 2006 at Reel/Frame No. 3247/0263 and/or on February 2, 2011 at Reel/Frame No. 4470/0743;

WHEREAS, Obligors have requested that the Administrative Agent release its Security Interest in the Collateral and all licenses, royalties, and other monies relating thereto, including goodwill, set forth in Exhibit A; and

WHEREAS, the Administrative Agent acknowledges full performance of the Obligations under the Credit Agreement, Security Agreement and related loan documents and accordingly has agreed to release its Security Interest in the Collateral, and all

licenses, royalties, and other monies relating thereto, including goodwill, set forth in Exhibit A;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby releases, relinquishes and discharges, with respect to each Obligor, any lien or security interest previously granted in the Collateral including, but not limited to, the Security Interest in the Collateral, terminates all of its right, title and interest in, to, and under the Collateral and any and all liens and encumbrances, and re-assigns to such Obligor any and all right, title or interest it may have in such Collateral.

The Administrative Agent hereby authorizes the Obligors or the Obligors' authorized representatives to: (a) record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Administrative Agent's lien on and security interest in the Collateral. The Administrative Agent agrees to execute and deliver to the Obligors all other instruments and other documents as may be necessary or proper to release Security Interest in the Collateral which had been granted under the Grants of Security Interest.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its duly authorized officer as of the date first written above.


