- 5 The same to be held and enjoyed by Assignee for its own use and for the use of its successors and assigns, fully and entirely and at least fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made;

- 6 And the Assignee accepts all such rights, titles and interest;
- 7 Assignor further agrees to refrain from any unauthorized use of the Assigned Trademarks in the United States, Canada or throughout the world, or any marks relating to or containing all or a significant portion of the Assigned Trademarks, and Assignor agrees to refrain from seeking to register as a trade-mark (any of) the Assigned Trademarks or any marks relating to or containing all or a significant portion of the Assigned Trademarks in the United States, Canada or throughout the world.
