RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS this "Release") is made as of December 20, 2012 and granted by JPMorgan Chase Bank, N.A., in its capacity as collateral agent (in such capacity, the "Agent") pursuant to the Intellectual Property Security Agreement dated as of August 21, 2007, among Apache Merger Sub, Inc. and Alliant Holdings I, Inc. (the "Borrowers"), Apache Holding Company, L.L.C. ("Holdings") and the guarantors listed on Schedule I hereto (each a "Pledgor" and together with the Borrowers, the "Pledgors"), and the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Capitalized terms used but not otherwise defined herein have the meanings set forth in the Security Agreement.

WHEREAS, pursuant to the terms and conditions of the Security Agreement, the Pledgors assigned and pledged to the Agent a security interest in all of its right, title or interest in or to the Trademarks including those set forth on Schedule II hereto, all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing (collectively, the "Trademark Collateral");

WHEREAS the Security Agreement has been recorded with the Assignment Division of the U.S. Patent and Trademark Office on September 14, 2007 at Reel 3621 and Frame 0846;

WHEREAS, the Agent acknowledges full performance of the Obligations under the Security Agreement and accordingly has agreed to release its Security Interest in the Trademark Collateral, and all Goodwill associated with such Trademarks and all Proceeds relating thereto, set forth in Schedule II hereto; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels, re-pledges, reassigns and releases to the Pledgors any and all goodwill, rights, title, interest, liens and security interests it has against the Trademark Collateral, without warranty or recourse.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to the respective Pledgors, including, but not limited to, any and all rights to sue for and collect damages for past infringements.

The Agent hereby authorizes the Pledgors, or the Pledgors' authorized representatives to: (a) record this Release with the USPTO and/or any other applicable governmental office or Agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Agent in the Trademark Collateral.

This Release shall be construed in accordance with and governed by the law of the State of New York.
