## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made and entered into effective as of December 17, 2012, by ROBERT PETERSON, an individual, whose address is set forth on Exhibit D ("Peterson"), TWO SISTERS, INC., a Texas corporation whose address is set forth on Exhibit D ("Two Sisters", and together with Peterson "Assignor"), in favor of RVNB Holdings, Inc., a Delaware corporation, whose address is set forth on Exhibit D ("Assignee").

WHEREAS, Peterson is the owner of the trademarks listed on Exhibit A, attached hereto, and Two Sisters is the owner of the trademarks listed on Exhibit B attached hereto (the marks on Exhibits A and B, collectively the "Trademarks"), and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, all applications and registrations therefor, and all claims for damages arising out of or relating to past or continuing or future infringements thereof, if any, with the right to sue for and collect such damages and any and all United States and/or foreign trademark (or service mark) registrations which may issue on such applications in the future, and (b) all right, title and interest or Assignor in and to the trademark licenses described on the attached Exhibit C ("Existing Licenses").

Assignor hereby covenants and warrants that it has the full right to convey the above-described worldwide right, title and interest by this instrument, free of any encumbrances and that no other agreement has been or will be executed in conflict herewith. Notwithstanding anything herein to the contrary, (a) the Trademarks are subject to, and the Assignee takes title to the Trademarks subject to, the existing licenses described on Exhibit C.

Assignor and Assignee shall deliver any and all other instruments or documents required to be delivered pursuant to, or necessary or proper in order to give effect to, all of the terms and provisions of this Trademark Assignment, and agrees to perform all affirmative acts which may be necessary or desirable to perfect the above-described transfer of the rights conveyed hereby or to maintain said registrations before both the United States Patent and Trademark Office, at Assignee's expense, as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to said Trademarks.

Assignor further authorizes the Commissioner of Patents and Trademarks of the United States, and the appropriate official in any other country, to issue any and all additional trademark and service mark registrations or amended registrations that have been or may be granted upon any application or petition for same, to Assignee, its successors and/or assigns.

This Assignment may be executed in any number of counterparts and by the parties hereto in separate counterparts, and delivered by facsimile or other means of electronic transmission, each of which shall be deemed to be one and the same instrument and an original document.

This Trademark Assignment and the covenants and agreements herein contained shall be binding upon and inure to the benefit of the parties to the Purchase Agreement and their respective successors and permitted assigns.

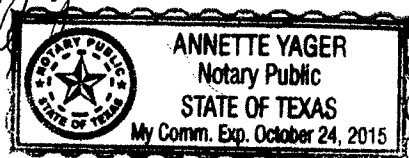

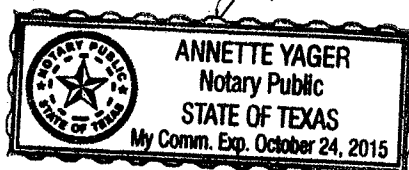

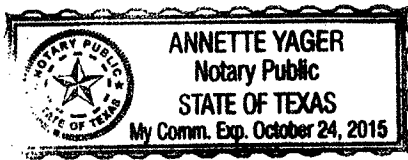
