**DECLARATION OF EZRA SUTTON**

I am counsel for Assignor Accessory Network Group, L.L.C. and its successor entity, Assignee AHQ, L.L.C. On August 21, 2012, I filed electronically on behalf of Assignor the recordation of an Assignment of 20 trademarks. The recordation consisted of the transfer of ownership of 20 listed trademarks from Accessory Network Group, L.L.C. to its successor AHQ, L.L.C. Attached is the actual assignment document, executed on June 24, 2012. Also attached is the August 21, 2012 confirmation receipt from the ETAS system online. In addition, attached is the Notice of Recordation issued on August 23, 2012, by the Assignment Recordation Branch, confirming the transfer of the 20 trademarks on Reel/Frame **4846/0822**.

Subsequently, it has come to our attention that Registration Number 2,585,562 for the mark ACCESSORY ZONE was inadvertently included on the list of 20 trademarks, and on behalf of AHQ L.L.C., this is to confirm that it should **not** have been included in the assignment recordation filed on August 21, 2012. Specifically, the correct owner of Registration Number 2,585,562 was and still remains Accessory Zone, L.L.C., not the Assignor or the Assignee indicated above. 
