ASSIGNMENT

Furthermore, to the extent this Agreement imposes any obligations upon Assignor and Assignee, same shall be binding upon and shall inure to the benefit of the parties hereto, their respective heirs, personal representatives, successors and assigns and shall be interpreted in accordance with the laws of the Commonwealth of Pennsylvania.
