TERMINATION OF SECURITY AGREEMENT

WHEREAS, SOS SECURITY INCORPORATED ("SOS"), New Jersey corporation executed and delivered in favor of TD BANK, N.A. (the "**Lender**"), that certain Intellectual Property Security Agreement dated as of August 1, 2008 (the "**Security Agreement**"); and

WHEREAS, at the time the Security Agreement was executed, SOS was the owner of the trademarks, registrations and applications therefor (the "**Trademarks**") listed on Schedule A hereto and the goodwill of SOS's business associated therewith; and

WHEREAS, pursuant to the Security Agreement recorded with the United States Patent and Trademark Office on August 5, 2008 at Reel/Frame 3829/0720, SOS granted to the Lender, inter alia, a first priority security interest in and to the Trademarks, the registrations and applications thereof, and the goodwill associated therewith; and

WHEREAS, the parties now desire to terminate the Lender's security interest in the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, the Lender hereby agrees as follows:

1. The Security Agreement is hereby terminated, and of no further force or effect.
2. The Lender hereby releases its security interest and conveys back to SOS all of the Lender's interest in and to the Trademarks, the registrations and applications thereof and the goodwill associated therewith.
3. The Lender agrees to execute such statements or other documents, as may from time to time be determined to be reasonably necessary, to evidence the release of any and all liens or interests of record in the Trademarks, registrations and applications.
