**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of December 21, 2012, is made by Credit Suisse AG, Cayman Islands Branch, in its capacity as Administrative Agent (the "Administrative Agent") pursuant to the Guarantee and Collateral Agreement, dated as of March 24, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") among RedPrairie Holding, Inc., RedPrairie Corporation, SofTechnics, Inc. (now known as RedPrairie Corporation) (the "Grantor"), certain other subsidiaries of RedPrairie Corporation party thereto, and the Administrative Agent.

WITNESSETH

WHEREAS, the Grantor and the Administrative Agent are parties to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Grantor executed the Trademark Security Agreement dated January 12, 2011 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on February 1, 2011 at Reel/Frame No. 4465/0209, pursuant to which the Grantor granted to the Administrative Agent a lien on and security interest in its right, title and interest in the Trademark Collateral (as defined in the Trademark Security Agreement);


WHEREAS, the Grantor has requested that the Administrative Agent release its lien on and security interest in and to all of its right, title and interest in and to the Trademark Collateral.


