## ASSIGNMENT OF TRADEMARK RIGHTS

This ASSIGNMENT OF TRADEMARK RIGHTS (this "Assignment") is made and effective as of the \_\_\_\_ day of ~~March~~ 27, 2012 (the "Effective Date"), by and between TECHSKILLS LLC, a Delaware limited liability company, ("Assignor") in favor of MYCOMPUTERCAREER.COM AT COLUMBUS, LLC, an Ohio limited liability company ("Assignee").

### PREMISES:

### AGREEMENT:

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby assign, convey and transfer unto Assignee all of Assignor's entire right, title and interest in and to the Marks, together with the goodwill appurtenant to the Marks and the entire right, title, and interest in and to any and all claims and demands, Assignor may have either at law or in equity arising out of past, present or future infringement of the Marks.

Assignor, to the extent applicable, hereby authorizes and requests the United States Commissioner of Patents and Trademarks and other corresponding officials of other jurisdictions, as appropriate, to record this instrument to reflect Assignee as the owner of the Marks.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of North Carolina without regard to the principles of conflicts of laws thereunder.
