Company hereby authorizes the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office, Canadian Intellectual Property Office, and the empowered officials of any other applicable offices and governments to issue or transfer all said Assigned Trademarks, Assigned Domain Names, and all applicable Unlisted IP to Parent, as assignee thereof, or otherwise as Parent may direct.

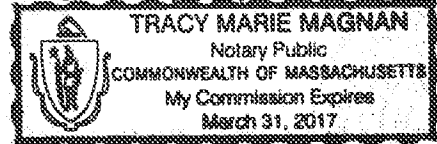

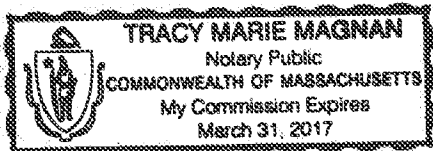
