**RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of December 28, 2012, is made by General Electric Capital Corporation, as attorney-in-fact for Deutsche Bank Trust Company Americas, as Second Lien Collateral Agent ("Agent"), under the Second Lien Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Second Lien Credit Agreement).

WHEREAS, in connection with that certain Second Lien Credit Agreement dated as of April 20, 2007 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements, and copyright security agreements entered into in connection therewith or in connection with prior versions thereof, the "Second Lien Credit Agreement"), among RoadLink USA, Inc. (the "Borrower"), the other Credit Parties signatory thereto, Deutsche Bank Trust Company Americas for itself, as a Lender, as the Agent for all Lenders and the other financial institutions party thereto, the Lenders agreed to make extensions of credit to the Borrower;

WHEREAS, in connection with the Second Lien Credit Agreement, and pursuant to those certain Trademark Security Agreements and that certain Copyright Security Agreement described on Annex I attached hereto (collectively, the "Security Agreements"), the Borrower granted security interests in certain intellectual property owned by it to Agent, including those listed on Annex I attached hereto (collectively, the "Intellectual Property Collateral"); and

WHEREAS, the Security Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") and in the United States Copyright Office (the "Copyright Office"), as applicable, on the dates and in the reels and frames and volumes and document numbers, as applicable, as set forth on Annex I hereto.


