**TRADEMARK ASSIGNMENT**

This TRADEMARK ASSIGNMENT ("**Trademark Assignment**") dated as of December 28, 2012 ("**Effective Date**"), State Street Corporation, a Massachusetts corporation, and having a usual place of business at One Lincoln Street Boston, MA 02111 ("**Assignor**") and The Tuckerman Group, LLC, a Delaware limited liability company, and having a usual place of business at 10 South Wacker Drive, Suite 3250 Chicago, IL 60606 ("**Assignee**"). Both Assignor and Assignee are collectively referred to herein as the "**Parties.**"

WHEREAS, Assignor holds all right, title and interest in and to the service mark TUCKERMAN registered on the Supplemental Register in the United States Patent and Trademark Office on June 29, 1999, and having Registration No. 2258293 (the "**Mark**") and the goodwill of the business symbolized thereby;

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all of the Assignor's rights, title and interest in and to the Mark from Assignor, together with the goodwill of the business symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee any and all worldwide rights, title and interests Assignor holds in and to the Mark (including statutory, common law and contractual rights), and any and all goodwill connected with and symbolized by, in, to and under the Mark, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors and assigns to the end of the term or terms for which the Mark are granted, and in and to all income, royalties, damages and payments now or hereafter due or payable with respect to the Mark, including in and under all causes of action (either in law or in equity), and the right to sue, counterclaim, and recover for past, present and future infringement of the Mark.
2. The Parties hereby request and authorize the relevant authority at the United States Patent and Trademark Office and/or the applicable foreign authorities to record Assignee as the assignee and owner of the Mark.
3. This Assignment is binding upon and inures to the benefit of the Parties hereto and their respective successors and assigns. This Assignment and the rights and obligations of the Parties hereunder shall be governed by, and construed in accordance with the laws of the State of Delaware.
