**ASSIGNMENT OF TRADEMARKS AND SERVICE MARKS

Assignment: Assignor hereby assigns, grants, transfers, and otherwise conveys to Assignee all of Assignor's worldwide common law and statutory rights, title, and interest in and to the Marks, including but not limited to (i) all of Assignor's legal, equitable, and beneficial ownership of the Marks, (ii) all of the goodwill of the business appurtenant to the use of the Marks, (iii) those applications and registrations identified on Schedule 1, and (iv) the exclusive right to sue, in Assignee's name and for the sole benefit of Assignee, for any and all past claims or causes of action.

Power of Attorney: In addition, Assignor hereby appoints Assignee as its attorney-in-fact with full power and authority to prepare the relevant Schedule 1 and execute, file, and record any and all further documentation as may be necessary or required for the recordation of this Assignment in the relevant Trade Marks or other agencies in any jurisdiction whatsoever, and in the name and on behalf of Assignor, in Assignor's place and stead, and with full power of substitution for the purposes set forth above.
