**TERMINATION OF SECURITY INTEREST**

THIS TERMINATION OF SECURITY INTEREST AND RELEASE OF COLLATERAL is made effective as of December 31, 2012 (the "Effective Date") by Bank of America, N.A., successor by merger to LaSalle Bank National Association, formerly LaSalle National Bank (the "Bank").
