**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination and Release"), dated as of December 28, 2012, is made by SILICON VALLEY BANK., a California bank, located at 380 Interlocken Crescent, Broomfield, Colorado 80021 (the "Bank") in favor of VERISAE, INC., a Minnesota corporation, located at 100 North Sixth Street, Suite 710A, Minneapolis, Minnesota 55403 (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement between Grantor and Bank dated as of December 2, 2009 (the "Loan Agreement"), Bank made the Loans to Grantor on the condition that Grantor grant to the Bank a security interest in certain Collateral. All capitalized terms used herein that are not otherwise defined shall have the meanings ascribed to them in the Loan Agreement;

WHEREAS, pursuant to that certain Intellectual Property Security Agreement between Grantor and Bank dated as of December 2, 2009 ("Intellectual Property Security Agreement"), Grantor granted to the Bank, a continuing security interest in, and pledged to the Bank, all of Grantor's right, title and interest, whether presently existing or hereafter acquired, in and to all of the Intellectual Property Collateral, including those Copyrights set forth on Schedule A attached hereto, those Patents set forth on Schedule B attached hereto and those Trademark set forth on Schedule C attached hereto;

WHEREAS, pursuant to that certain Addendum to Intellectual Property Security Agreement between Grantor and Bank, dated as of June 7, 2011 (the "Addendum"), Grantor granted to the Bank a security interest in certain additional patents as an addendum to the Intellectual Property Security Agreement;

WHEREAS, the Intellectual Property Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 9, 2009 at Reel 4111, Frame 0300;

WHEREAS, the Intellectual Property Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on December 9, 2009 at Reel 023627, Frame 0375;

WHEREAS, the Addendum was recorded in the Patent Division of the United States Patent and Trademark Office on July 7, 2011 at Reel 026554 Frame 0650;

WHEREAS, Grantor has paid all of its outstanding obligations to the Bank; and

WHEREAS, the Bank now desires to terminate and release the entirety of its security interest in and lien on the Intellectual Property Collateral (including the additional patents set forth in the Addendum).


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby terminates, releases and discharges any and all security interest and lien it has against the Intellectual Property Collateral (including the additional patents set forth in the Addendum), including without limitation those Copyrights set forth on Schedule A attached hereto, those Patents set forth on Schedule B attached hereto and those Trademarks set forth on Schedule C attached hereto.

The Bank shall, at Grantor's sole cost and expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Termination and Release.
